**TERMS AND CONDITIONS OF CONTRACT:** A non-refundable booking fee of \$1,000 is required with the submission of this contract. A booking is ratified upon receipt of this contract and the cashing of said initial booking fee. The final balance shall be paid no later than Friday before wedding date. Failure to make payments on time gives Red Leaf Films the right to refuse to carry out the services and client shall forfeit all fees paid. Extreme professional care and diligence will be exercised by Red Leaf Films in the provisions of the video services, but no warranty is expressed or implied. The filming and editing of video footage shall be carried out at the artistic discretion of Red Leaf Films which shall film and edit as far as possible in compliance with any special wishes of the client, but no special requested footage is guaranteed to be included (any special requests must be made and accepted by us prior to wedding day). The client accepts the work shown on our website as an example of the general style and quality of Red Leaf Films, but each photographic situation shall produce different results. The client understands that no specific length of finished video is implied or guaranteed. The client acknowledges that there are elements beyond Red Leaf Films control in providing video services. These could include, but are not limited to the following: faulty material, equipment failure, loss of master tapes or memory cards, civil disturbances, weather conditions, acts of God, non attendance in the event of an accident or illness occurring on or before the date when services are to be provided. Any liability of Red Leaf Films shall be limited to a refund of any money paid under this agreement in full and final satisfaction of any damage or loss suffered by the client. The client agrees to grant Red Leaf Films the right to use any video taken for promotional purposes without compensation or liability to the client. It is the responsibility of the client to advise any participants and attendees that the event will be videotaped. The client agrees to immediately advise Red Leaf Films in writing of any alterations in the details including postponement or cancellation of the services. In the event of postponement or cancellation of services, all fees paid up to that point will be forfeited. Client acknowledges that we do not offer "proofs" but only a final product and that finished DVD's are provided on DVD-R and that their player is specified to play DVD-R. Any additional editing beyond the final product requested by the client due to a change in taste or information, including additions, omissions, retractions or alterations, will be subject to additional charges at the rate of \$150 per hour. Requests for additional editing must be made within 48 hours of delivery of final product as all original material used in editing is removed from our editing system after that time. Any overtime required past the scheduled time indicated on this contract shall be billed at the rate of \$400 per hour in 15 minute increments. Any overtime balance due shall be paid prior to delivery of any DVDs.
